**INTERMEDIARY OR UMBRELLA COMPANY PAY INFORMATION**

The worker is being paid through an intermediary or umbrella company: a third-party organisation that will calculate the worker's tax and other deductions and then pay worker for the work undertaken for the hirer. We will still be finding the worker assignments.

The money earned workers assignments will be transferred to the umbrella company as part of their income. They will then pay worker their wage. All the deductions made which affect workers wage are listed below. If the worker has any queries about these, they can contact us.

Workers payslip may show them as an employee of the umbrella company listed below.

<b>Any business connection between the intermediary or umbrella company, the employment business and the person responsible for paying you:</b>	The employment business and Parasol are not connected. Parasol is independent to Venn Group. A contract for services will be in place between Parasol and Venn Group.
<b>Expected or minimum gross rate of pay transferred to the intermediary or umbrella company from us:</b>	£11.15 per hour to Parasol Ltd

<b>Deductions from intermediary or umbrella income required by law:</b>	<ul style="list-style-type: none"> <li>Employers National insurance calculated at 13.8% of the gross pay figure (above secondary threshold of £166 per week)</li> <li>Apprentice Levy is calculated at 0.5% of the gross pay figure.</li> <li>Auto enrolment employers pension contributions at 4% of national living wage.</li> </ul>
